E. Universal Licensure

The Committee discussed standards and requirements for universal licensure for home inspectors pursuant to A.R.S. §32-4302.

The Committee discussed training and education standards and requirements for home inspectors pursuant to A.A.C. R4-30-247 and the potential future implementation of continuing education standards for home inspector's Certified home inspector, David Schwartz, appeared virtually for discussion.

G. Parallel Inspectors: Qualifications and Responsibilities

The Committee discussed qualifications and responsibilities for parallel inspectors pursuant to A.A.C. R4-30-102. AAG Scott Donald was present to provide legal advice. Certified home inspector, David Schwartz, appeared virtually for discussion.

H. Parallel Inspections: Candidate requirements and Ramifications of inadequate training

The Committee discussed requirements to become a parallel inspector and recent issues noticed on parallel inspection reports.

I. EAC Members: Recruitment, Qualifications, Application Evaluations and Investigation Recommendations

The Committee discussed qualifications for becoming an EAC member and the current recruitment process, issues noticed by the Committee concerning the evaluations of applications by EAC members, and reviewed the Board's current investigation requirements pursuant to A.A.C. R4-30-120.

The Committee discussed updating the current Home Inspector Report Checklist Supplement at a future meeting.
