

This time of year, with the end of legislative sessions and graduations, is a time for many people to reflect upon achievements, hardships and plans for the future.

I had the opportunity and the privilege to attend the Arizona State University Spring 2016 Commencement and Convocation. I attended in support of a landscape architect graduate who interned with me at ADOT who was being awarded "The Alumni Association Outstanding Graduate Award." During the ceremony, ASU President, Michael Crow, admonished graduates and reminded the audience of the importance of not only education, but also the application of that

education in performance of all the various endeavors that graduates choose to pursue.

Then it dawned on me that in 1966 I was listening to the President of Utah State University at my own graduation in Landscape Architecture & Environmental Planning make very similar remarks. It was a rude awakening to me that 50 years in professional practice had flown by!

Reflecting on the end of the Legislative Session, I will, unfortunately keep a less happy memory because this past Session, the Legislature endeavored to deregulate the practices of landscape architecture and geology in Arizona. The Board of Technical Registration has, for so many years, regulated the professional practice of Architects, Engineers, Geologists, Home Inspectors, Land Surveyors, Landscape Architects, and the Alarm industry, in order to protect the public by ensuring that these professionals provide competent service. The Board has consistently taken action to ensure that qualified professional registrants, as

they provide services, maintain adequate knowledge, provide work that demonstrates that knowledge and ethical commitment, and when it falls short, taken appropriate disciplinary action.

Although landscape architects are still required to practice with registration by the Board, the geologists may now choose to voluntarily become registered or practice without registration. That "choice" may endanger public health, safety and welfare.

If I could sum up my memories of 2016 to this point, and provide any "wisdom" to interested stakeholders going into the future, I would urge them to pay attention to and anticipate future attempts to deregulate other learned professions. I also have some words and phrases that come to mind for those lawmakers: "open dialog," "constant observation," due diligence," "active participation," "if it's working why change it?" "walk in the shoes of another to know and understand," and, "take the hand we have been dealt and make the best of it." Hopefully, someone will listen.

Director's Comments



Democracy in Action

The 2016 Legislative session was, by far, the most challenging session for the Board in recent history. As a result of the Board's self-audit in its sunset year, and, having taken very seriously the Governor's directives to operate more effectively, and to become more "relevant" to its licensed populations and the public, the Board ran four bills of its own this session.

Senator Yee, Chairman of the Board's Committee of Reference, sponsored SBIII9, the agency's continuation bill, and SBI422, the Board's first "omnibus" bill in decades. The Continuation bill proposed continuing the agency for eight (8) more years. The Omnibus bill was the Board's first attempt to revise its practice act. Additional revisions are planned for another bill to be offered next session.

This year's Omnibus bill proposed removing the archaic terms "architect in-training" and "landscape architect in-training" from the Board's practice act. It proposed clearer language for the law requiring registration to call oneself an architect, engineer, and landscape architect, and it clarified existing language requiring that one of the engineer members of the Board be a civil engineer. The bill clarified language relating to home inspectors, and it proposed to raise the requirement to obtain registration as a surveyor from 6 to 8 years. However, Rep. Petersen sponsored an

amendment to eliminate that provision. Finally, the bill requires former registrants who have let their licenses be cancelled and have remained out of practice for more than 5 years to take national qualifying exams before they can be reregistered.

Sen. Kavanaugh sponsored two bills for the Board this session: SB1256, the Board's "Dereg" bill, and SB 1162, relating to the Alarm industry. SBI 162 passed out of the Senate but was never assigned to a committee in the House. Although, SBI162 proposed changes to the alarm industry that would have made fingerprinting requirements less burdensome and costly for applicants, those changes will have to wait until next session. SB1256, which proposed the deregulation of the Assayers, the Drug Lab Program, and Remediation Specialists, passed with one minor amendment; now formerly registered Assayers may refer to themselves in professional correspondence as Emeritus Assayers.

HB2613, the Governor's initiative to deregulate numerous occupations in Arizona, sponsored by Representative Petersen, was arguably the greatest legislative challenge to two Board regulated professions this session. The bill initially proposed the deregulation of two of the Board's learned

professions: Landscape Architects and Geologists, on the premise that deregulation would stimulate the State's economy. Landscape Architects and Geologists quickly organized to oppose the bill, and with great support from affiliated science and design professions, an impressive number of them appeared at the first committee hearing in the House and testified against it. The Governor agreed to remove the Landscape Architects from the bill after learning that they were registered in every state in the U.S. and in Canada. Rep. Petersen later amended the bill to make registration for Geologists 'voluntary.'

The Board exists to protect the public from those unqualified to practice safely and unscrupulous enough to harm Arizona citizens. Regulation of learned professions has been proven to stimulate the economy by encouraging qualified practice and promoting public protection.

Thank you to all who tried to explain the importance of regulation and public protection to the Governor and the Legislature, and thank you for supporting your colleagues in these related professions.

BTR Tours Palo Verde



On March 23, 2016, members of Board staff and Surveyor Member, Jason Foose, attended a tour of the Palo Verde Nuclear Generating Station. Palo Verde has been the nation's largest power producer since 1992. It provides clean, nuclear power to 4 million people in Arizona, California, New Mexico and Texas. The site of the Plant comprises over 4,000 acres, approximately 55 miles west of Phoenix. The site was selected in the late 1960s because of its low seismic activity.

Palo Verde is the only nuclear plant in the United States that does not sit on a large body of water. To cool its reactors, the Plant recycles more than 20 billion gallons of municipal effluent water each year to meet its cooling needs. The treated water is piped 36 miles from surrounding cities to two storage reservoirs with a combined capacity of approximately one billion gallons. These reservoirs provide about 14 days storage of water for the three reactors to operate at full capacity during peak conditions in the hot, summertime weather.

Palo Verde is managed by Arizona Public Service (APS,) which owns the largest share among the seven utilities that own the Plant. Other owners include Salt River Project (SRP,) Southern California Edison, El Paso Electric, Public Service Company of New Mexico, Southern California Public Power, and Los Angeles Department of Water and Power.

Palo Verde is very safety conscious and vigorously promotes and values the need for registered engineers, in all categories, to maintain the Plant's safe operations and to plan for all its future contingencies.

Board Member Neal Jones Wins Top Architect Honor



Neal Jones, AIA, of Jones Studio, who serves as an architect member of the Board, was awarded the American Institute of Architects 2016 Institute Honor Award for Architecture, for his project, the Mariposa Land Port of Entry Expansion and Modernization. The AIA noted that Jones' project was "both a source of inspiration and a timely reminder that quality is not a luxury, but proof of the durability of a society's values and a sure sign of its health." Congratulations to Neal and the Jones Studio for this honor.

Folk regretted not taking more geology classes because the college had a "really cool fieldwork program at Red Lodge in Montana every year."

Surveyors' Apprenticeship

United Surveyors of Arizona, Inc., the "new" surveyor association in Arizona, is sponsoring a Surveyor Assistant apprenticeship program with the Arizona Builders Alliance in order to encourage young, college age students to enter the Surveying profession.

Among other minimum standards, the apprenticeship program will not accept anyone younger than 16. It will promote proper supervision of on-the-job training, and maintain adequate facilities to train the apprentices. The apprenticeships will require a minimum of 2000 hours and related and supplemental instruction in math, algebra, geometry and trigonometry. Safety, note keeping, use and care of basic tools and equipment, maps and plan reading, public relations, survey law, ethics and other subjects will also be taught and required for graduation.

Kent Groh, President of United Surveyors of Arizona, Inc., is excited about the apprenticeship program. "Hopefully, this apprenticeship will provide young people with a stepping stone into the surveying profession," Groh said. Completion of the apprenticeship might provide an applicant with experience and/or education toward qualification to take the national Fundamentals of Surveying Examination.
